public reactionsboth pro and conthe beachfront property that was home to the beloved Positano Restaurant along Compo Cove in Westport has hit the market, now cleared for residential use. The restaurant relocated to the **Westport Country** Playhouse, opening its doors in 2015. Its former sandy site, measuring .13 acres, is now listed for \$4.5 million, a bigticket item for sure, given that you'd have to build a house on it. But the location is unbelievable: directly on the sand with soul-stirring views over Long Island Sound, Andrew Whiteley of Al Filippone Associates, affiliated with William Raveis Real Estate in Southport, has the listing. 203-258-1595.

4,540-square-foot interiors take in expansive Long Island Sound views, from the living room with its stunning river-stone hearth to the master suite, built into a turret, featuring a gas fireplace and private balcony. But the home's most dramatic feature is the cupola centered over the main staircase, flooding the three floors with light and capping its shingled rooftops with a dramatic flourish. The home lists with Michelle Genovesi of Michelle&Company Real Estate, William Raveis.

Just a few miles up the coast on Beachside Avenue is a circa-1911 Tudor on 7.7 acres. It clocks in as one of Westport's largest waterfront properties—and at \$32 million, as the most expensive listing in town. The property has long sat at the top of the market, price-wise: Marlo Thomas and Phil Donahue sold it in 2006 for \$25 million, breaking all records, to financier Herbert Allison Jr. The TIAA-CREF executive who ran both Fannie Mae and, after the crash, the Troubled Asset Relief Program (TARP) program for President Obama, passed away a few years ago. The main house measures nearly 8,500 square feet, offering seven bedrooms and nine bathrooms. But the spread's most impressive feature is the grand sweep of lawns that roll toward 365 feet of private waterfront, including a sandy beach. Victoria Fingelly of William Pitt Sotheby's International Realty has the listing.

## A CLASSIC COLONIAL

THERE'S NOT A HOUSING STYLE MORE CLOSELY ASSOCIATED WITH CONNECTICUT than the stately Colonial, and an especially handsome model is on the market in Sherman, listed for \$599,000. Called Strawberry Fields Farm, the spread comes with a farmstand fashioned from a post-and-beam barn from which the current owner, Carol Royal, sells organic produce, herbs and maple syrup. The 12.8 acres also offer a sugar shack, chicken coop, apiary, fruit trees and a stream-fed pond. When Royal purchased the foreclosed, circa-1775 property, she said she practically needed a Hazmat suit to step inside the main house. It was a labor of love to restore the wide-plank chestnut floors, four fireplaces, including one with a bechive oven, and exposed beams and wainscoting. Today the 3,200-square-foot interiors offer four bedrooms and four bathrooms. And, fun fact, it was likely visited by George Washington, who would have stopped by to see one of his military captains, William Giddings, the original homeowner. The farm is listed with Irit Granger of William Pitt Sotheby's International Realty.
